

### 1. What are cookies?

A cookie is a small piece of data that websites collect from visits and that can identify a web-enabled user device such as a computer, laptop, mobile, smartphone or tablet. ## 2. What cookies do we use and why?

#### **Necessary:**

These are essential to enable you to move around the website and use its features.

#### **Preferences/Functional:**

These allow the website to remember choices you make (such as your username). The information these cookies collect is anonymised (i.e. it does not contain your name, address etc.) and they do not track your browsing activity across other websites.
